Para-LPN Stipend

With the State issued new salary scale for school nurses, our Para-LPN salary scale is not comparable like

it has been in the past. Since the Para-LPN salary scale has already been set and approved for FY24.

adding a \$2,000/year stipend is the best option at this time. We can re-evaluate the Para-LPN salary

schedule for FY25 and eliminate the stipend at that time.

FY23 FY24

Para - \$22,002 Para - \$22,443

Para-LPN - \$26,175 Para-LPN - \$26,699

There are currently two Para-LPNs so the expense will be minimal.

Bus Driver Training Stipend

This will not be a fixed dollar annual stipend, rather, a per driver trained amount (\$200). Bus Training

- 1. Set course up with Calhoun Community College (up to 1 hour)
- 2. Video Series at Bus Shop (3-4 hours)
- 3. Pre-Trip Training (up to 4-6 hours)
- 4. Air Brake Training (2 hours)
- 5. Cone Practice (Backing, Turns) (up to 4-6 hours)
- 6. Driving Practice (7 to 10 hours)
- 7. Complete Required Paperwork (up to 1 hour)
- 8. Approve for State School
- 9. Complete Federal Registry (up to 1 hour)

Total Training Time: 23-31 hours

Trained 20 drivers in 2022-2023. Average about 18-20 per year.

(We will begin charging other school systems \$200 when we train their bus drivers to cover the cost of training stipend for them.)
